I understand and agree that by signing this Waiver and Acknowledgement I am releasing, discharging and covenanting not to sue on behalf of myself, my personal representatives, heirs, and next of kin, *Panthers Hockey LLLP, Panthers Hockey LC, PHGP LLC, Florida Panthers Hockey Club, Ltd., Arena Operating Company, Ltd., Arena Development Company, Ltd., BankAtlantic Center., Broward County, the Broward County Board of Commissioners and SMG* and all of their respective officers, agents, directors, employees, partners, shareholders, and representatives and any and all of their respective subsidiaries or affiliates (collectively, the "Releasees"), from any and all claims, demands, or causes of action based on fault or negligence or not, including, but not limited to, any claim whatsoever on account of first aid treatment or service rendered during the promotional activities of *Florida Panthers Hockey Club, Ltd.*
